

SCANSOURCE PARTNER FIRST 2026 REGISTRATION PROMOTION SWEEPSTAKES

OFFICIAL RULES

The ScanSource “Partner First 2026 Registration Promotion” (the “Sweepstakes”) is sponsored by ScanSource, Inc. (“ScanSource” or “Sponsor”) and consists of sweepstakes beginning 6/1/2026 and ending 7/31/2026 (“Registration Sweepstakes”). The Sweepstakes is open only to ScanSource resellers, which for purposes of these Official Rules, are defined to mean individuals who are legal residents of, and business entities that are domiciled in, the 50 United States and the District of Columbia and Canada (except the Province of Quebec), which at the time of participation are: (1) registered resellers, integrators or service providers of ScanSource in good financial standing with ScanSource; (2) Reseller Sales representatives (as defined by ScanSource in its sole and absolute discretion); and (3) 21 years of age or older (if an individual). Direct Marketers (“DMARs”), “e-tailers,” Distributors, Manufacturers and other competitors of ScanSource, as those terms are defined or interpreted by ScanSource in its sole discretion, are not eligible to participate in the Sweepstakes.

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT ENHANCE YOUR CHANCE OF WINNING. VOID IN PUERTO RICO, U.S. VIRGIN ISLANDS, U.S. TERRITORIES AND POSSESSIONS, THE PROVINCE OF QUEBEC, AND WHERE PROHIBITED OR RESTRICTED BY LAW.

1. SWEEPSTAKES PERIOD.

- (A) Sweepstakes Period. The Sweepstakes begins June 1, 2026, and ends July 31, 2026 at 11:59:59 p.m. (Eastern Time) (the “Sweepstakes Period”). For purposes of the Sweepstakes, a “day” begins at 12:00:01 a.m. (Eastern Time) and ends at 11:59:59 p.m. (Eastern Time). Sponsor’s clock is the official time-keeping device for this Sweepstakes.
- (B) Entry Periods. The Entry Period begins the first day of June 2026 and ends the thirty-first day of the Month of July 2026.

2. HOW TO ENTER. Resellers may enter and participate the Sweepstakes as described above during the Entry Periods the following ways:

1. Project Registration Entries. Resellers may receive automatic entries during Sweepstakes by registering for ScanSource Partner First 2026 and booking their hotel room, at Grand Hyatt Nashville, before July 31, 2026.
2. Mail-in Entries. A Reseller may also receive entries in each Registration Sweepstakes without purchasing products by hand-printing the Reseller’s name, address, city, state, zip, email, and phone number, and the words “ScanSource Partner First 2026 Registration Promotion” with the applicable Month for which the entry is intended on a 3”x 5” card, and mailing the card in a stamped envelope to: ScanSource Partner First 2026 Registration Promotion Sweepstakes Entries, ScanSource, Inc., 6 Logue Court, Greenville, SC 29615 (USA). A Reseller will receive one (1) entry in the Drawing for a mail-in card and that is (i) postmarked during such Entry Period and (ii) received by Sponsor within nine (9) days from the close of such Entry Period. *Only one (1) mailin Sweepstakes entry per stamped envelope will be accepted.*
3. Limitations. Limit a total of 1 Sweepstakes entry per person, regardless of method of entry.
4. General Participation Matters. No copies or mechanical reproductions of mail-in Sweepstakes entries will be accepted. Any illegible, unintelligible, incomplete, postage-due, or garbled entries are not permitted and will be disqualified and any entries not in conformance with these Official Rules will be disqualified. Neither Sponsor nor any of its employees, representatives or agencies, is responsible for lost, postage-due, late, damaged, delayed, destroyed, misdirected, incomplete, or illegible entries. Once submitted, entries become the exclusive property of

Sponsor and will not be acknowledged or returned. Proof of submission will not be deemed to be proof of receipt by Sponsor. By participating, participants give their express permission to be contacted by Sponsor by mail, email, facsimile and telephone. Any personal information collected in connection with this Sweepstakes will be used in accordance with Sponsor's privacy policy. By participating, participants agree to be bound by these Official Rules and by the decisions of the judges, which are final and binding in all respects. 3. **ELIGIBILITY.** The Sweepstakes is open only to "Resellers," which for purposes of these Official Rules, are defined to mean individuals who are legal residents of, and business entities that are domiciled in, the 50 United States and the District of Columbia and Canada (except the Province of Quebec), which at the time of participation are: (1) registered resellers, integrators or service providers of ScanSource in good financial standing with ScanSource and (2) 21 years of age or older (if an individual). Direct Marketers ("DMARs"), "e-tailers," Distributors, Manufacturers and other competitors of ScanSource, as those terms are defined or interpreted by ScanSource in its sole discretion, are not eligible to participate in the Sweepstakes. Officers, directors, and employees of Sponsor, participating suppliers and their parents, subsidiaries, and other affiliated companies, agents, and advertising and promotional agencies, and their immediate family members (defined as parents, spouse, children, siblings, grandparents) and those with whom they are domiciled, are NOT eligible to enter or win.
4. **SWEEPSTAKES DRAWINGS; ODDS.**
 - (A) Sweepstakes Drawings; Odds. Sponsor will select two (2) eligible prize winners in a random drawing, which will be held on or about August 15th, 2026 in Greenville, South Carolina. Winners will receive prize in Nashville, Tennessee, during ScanSource Partner Event, August 31-September 2, 2026. Limit one (1) prize per Reseller. Odds of winning the Sweepstakes depends on the number of eligible entries received in the Sweepstakes time frame.
 - (B) Skill-Testing Question for Canadian Residents. In the event that a selected potential prize winner is a Canadian Reseller/resident, in order to win the prize, the Canadian Reseller/resident must first correctly answer unaided a time-limited, mathematical skill-testing question by telephone at a predetermined mutually agreeable time. In the event that the selected Canadian Reseller/resident is unable or otherwise fails to correctly answer the skill-testing question, the Canadian Reseller/resident will forfeit prize, and Sponsor will have the right to randomly draw another eligible potential winner.
 - (C) Winner Requirements. Potential winners will be notified by email, telephone, or facsimile. In the event that a potential winner is a business entity Reseller (as opposed to an individual Reseller), the authorized officer(s) of the winning business entity Reseller may be required to designate an individual recipient of the prize by specifying such individual in writing prior to acceptance of the prize. Potential winners must comply with all of the terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements.

Potential winners may be required to sign and return an Affidavit of Eligibility and Release (an "Affidavit") within 14 days of notification/verification in order to receive the prize. In

the event (a) a potential winner cannot be reached for whatever reason after a reasonable effort has been exerted based on the information submitted by potential winner, (b) of noncompliance with the above or within any of the aforesaid time periods, (c) a potential winner is found to be ineligible to enter the Promotion or receive the prize, (d) a potential winner cannot or does not comply with the Official Rules, (e) a potential winner's prize notification or Affidavit is returned as undeliverable for whatever reason, or (f) a potential winner fails to fulfill the Affidavit-related obligations, the potential winner may be disqualified from receiving the prize and/or the Promotion, and Sponsor may, at its sole discretion, award the prize to an alternate potential winner by a random drawing from among the other eligible entries received. Unclaimed prizes may not be awarded.

In the event of a dispute as to the identity of a potential winner based on an email address, the winning entry will be deemed to be the authorized account holder of the email address submitted at time of entry. For purposes hereof, an "authorized account holder" is the natural person who is assigned to an email address by an Internet access provider, on-line service provider or other organization (e.g., business, educational, institution, etc.) that is responsible for assigning email addresses for the domain associated with the submitted email address.

- (D) General Prize Restrictions. All prize-winning Resellers must be in good financial standing with ScanSource at time of award in order to be eligible to receive prize. In the event that a prize-winning Reseller is not in good financial standing with ScanSource at such time, such Reseller will forfeit award. Prizes are non-transferable. Unless otherwise specifically provided for herein, all taxes or expenses, sales tax, luxury tax, and any other costs incurred in claiming or using any of the prizes, are the sole responsibility of the prize winner. No prize substitution or cash equivalent of prize, except at Sponsor's sole discretion, and then only for a prize of equal or greater value. Any difference between the actual value of any prize and the approximate retail value set forth in these Official Rules may not be claimed and will not be awarded.

5. **SWEEPSTAKES PRIZES.** Sponsor will award one (1) Sweepstakes Prize to two (2) eligible partners in the month August 2026. Each Sweepstakes Prize consists of one (1) Sweepstake Prize listed below (with the approximate retail value ("ARV") list below).
Sweepstakes Prizes: (a) (ARV \$200) gift card.

6. **GENERAL CONDITIONS.**

- (A) This Sweepstakes is subject to all federal, state and local laws and regulations. The laws of the United States of America shall be deemed to govern the Sweepstakes.
- (B) Acceptance of prize shall constitute and signify the winner's agreement and consent that Sponsor may use winner's (as well as Reseller's corporate representatives') name(s), address(es) (city and state only), biographical data, voice, likeness, image, statements, and prize information, in any and all media now existing or hereafter devised for illustration, promotion, art, editorial, advertising, trade or any other purpose whatsoever, in perpetuity, without attribution, notification, compensation or consents (except where prohibited by law), and winning Reseller hereby releases Sponsor from any liability with respect thereto. (Canadian residents need not consent to, or sign any, publicity release.)
- (C) Reseller, by participating, releases and agrees to hold harmless Sponsor, participating suppliers, and their parents, affiliates, subsidiary companies, advertising and promotion agencies, and agents and their respective directors, officers, employees, representatives and agents from any

and all liability for any accident, loss, tax liability, injury, death or damage of any kind, arising from participant's participation in this Sweepstakes or in any Sweepstakes related activity, or resulting from acceptance, possession, use or misuse of any prize, or while traveling to and/or from a location as part of or to obtain or use a prize. Without limiting the foregoing, all prizes are provided "as is" without warranty of any kind, either express or implied, including but not limited to, the implied warranties of merchantability, fitness for a particular purpose, or non-infringement. (Any and all guarantees and warranties on merchandise prizes are subject to the manufacturer's terms and conditions, and winners agree to solely look to such manufacturers for any such warranty or guarantee claim.)

- (D) Sponsor and its parents, affiliates, subsidiary companies, advertising and promotion agencies, and agents and contest administrators and their respective directors, officers, employees, representatives and agents are not responsible for any typographical or other error in the printing of the Sweepstakes, administration of the Sweepstakes or in the announcement of the prizes. Sponsor reserves the right to modify the Sweepstakes rules, terms and conditions without materially affecting the terms and conditions of the Sweepstakes.
- (E) Except where prohibited, participants agree that: (1) any and all disputes, claims, and causes of action arising out of or connected with the Sweepstakes, or any prize awarded, or the determination of the winner(s) shall be resolved individually, without resort to any form of class action, and exclusively under the laws of the State of South Carolina, USA and through the courts of Greenville County, South Carolina, USA; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering the Sweepstakes but in no event attorneys' fees; and (3) under no circumstances will participants be permitted to obtain awards for and participants hereby waive all rights to claim punitive damages, incidental damages, consequential damages or any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased. (NOTE: Some jurisdictions do not allow the limitation or exclusion of liability for incidental or consequential damages, so the above may not apply to you.) All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant or Sponsor in connection with this Sweepstakes shall be governed by, and construed in accordance with, the laws of the State of South Carolina, USA without giving effect to any choice of law or conflict of law provisions.
- (F) If for any reason the Sweepstakes is not capable of running as planned due to infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, human or technical errors, or other errors, printing errors, tampering, fraud, unauthorized intervention, technical failure, acts of God, natural disasters, wide spread illness, public health crisis or pandemic (e.g., COVID-19), terrorism, weather or any other causes beyond the control of Sponsor which corrupt or affect the administration, security, fairness, integrity, or proper conduct of the Sweepstakes, Sponsor reserves the right at its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify or suspend the Sweepstakes. In the event of the cancellation, termination, or suspension of the Sweepstakes, Sponsor will only award the number of prizes awarded up to the date of termination, cancellation or suspension.
- (G) Sponsor assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, registrations or entries. Sponsor is not responsible for any problems or technical malfunction of any telephone network or telephone lines, computer on-line systems, servers, or providers, computer equipment, software, failure of any registration, email or entry to be received by Sponsor on account of technical problems, human error or traffic congestion on the Internet or at any website, or any combination thereof, including any injury or damage

to a participant's or any other person's computer relating to or resulting from participation in the Sweepstakes or downloading any materials in the Sweepstakes. Sponsor is not responsible for the inability to award all or any part of any award due to errors, delays or interruptions due to acts of God, natural disasters, widespread illness, public health crisis or pandemic (e.g., COVID-19), terrorism, weather or any other similar event beyond Sponsor's reasonable control.

(H) **WARNING:** ANY ATTEMPT BY A PARTICIPANT OR ANY OTHER PERSON TO DELIBERATELY DAMAGE THE WEBSITE (OR ANY SPONSOR WEBSITE) OR UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES OR OTHER REMEDIES FROM ANY SUCH PERSON(S) TO THE FULLEST EXTENT PERMITTED BY LAW, INCLUDING SEEKING CRIMINAL PROSECUTION.
